The proposed program activities include academic enrichment, college and career preparation, paid internships, personal/social-emotional development and parent engagement components. The retention goal is to help CUSD keep 60 students engaged for a minimum of 30 days. To encourage participation and completion of goals there is a tiered recognition plan. Participants can earn new Chromebooks, gift cards, certificates and depending on Covid restrictions, special events. With parent/guardian approval, students' accomplishments will be featured in media, social media, or website announcements.

The Chester Education Foundation will use non-school district funds to support technology purchases, student stipends, and incentive gift cards.
