A Public Meeting of the Receiver of the Chester Upland School District was held this evening at the Administration Offices, 232 West 9th Street, 1st Floor, Chester, Pennsylvania.

The Receiver's meeting opened with a call to order by Interim Receiver, Dr. Gregory Thornton and the Pledge of Allegiance.

REPORT FROM THE SUPERINTENDENT

I wanted to take a moment tonight to acknowledge Mr. Marvin Newton and the work that we've been doing around the facilities. Many of you know that we went and we went to court a couple months ago. I mentioned that we had schools that we were going to have to close during the winter because of our boiler situation and our heating system situation to most of the schools. And you also, the judge, you recall, the judge asked us to put a report together and send it to the department of education and he wanted to hear back from us. Well I don't do facilities reports, I have them done and this case, Mr. Marvin Newton went to work and you got the engineers in, and anyone in here we needed to, and as a result of that, the state has sent us \$375,000 to work. This is what happened and I want this as a matter of record. They gave us a interest-free transitional loan.

Now, I made it clear to the department of education that we were not in a position to accept a loan because that means you need to pay it back. And then we weren't in the position to pay it back, and I wanted them to know that we don't plan to pay this back and we have a letter that's going to the judge tomorrow and that that letter to the judge will say the same thing, that we appreciate this \$375,000 and get us through the winter. And Mr. Johnson, I want to be really clear about this, to get us through the winter. I don't know how many winters this is going to get us and my hope is it gets us through this one. But I really want to acknowledge Mr. Newton who, I don't like the term above and beyond because it's our job. But when you go on 24 hour, 24/7 that is something I would submit to it that may be above and beyond. So thank you Mr. Newton, and let me give him a report that says that.

And Toby Farms, the two boilers were finished yesterday. So we have two new boilers in Toby Farms and it's something that we haven't thought about in the past, but we are thinking about it now, that each individual classroom is being visited, so that we could adjust the temperatures in each classroom. So Toby by February 15th should have the classrooms fixed and the boiler room fixed. We're waiting for a boiler in CUSA. We expected that boiler comes in when it's supposed to that by March 7th, CUSA will be fixed.

Main Street by February 28th there's a lot of work that we needed to do with Main Street and again, what's happened in the past is we've been replacing the affected boilers, but we haven't been in the individual classrooms. So we're going into individual classrooms in these buildings now and where the boilers have been replaced and STEM and now we're adjusting each of the rooms. That's why he's the man. So thank you again. And let the record reflect that we have once again stated that we are in no position to repay a loan. Okay? Thank you. All right. That's my report.

PUBLIC COMMENTS

Ali Watley - Thank you for letting me talk. My name is Ali Watley, again and I'm very concerned about my daughter's education and it's apparent to me that no one is concerned about Ranisha's education. My daughter had already been suspended for more than 10 days, which is beyond what the law says for students receiving special education services. I went to school numerous times to discuss a plan with no success. Mr. Brown, Assistant Principal, and Ms. Cameron, Principal of Chester High School had, on several occasions, humiliated me and in the presence of parents, students and staff, I've heard Dr. Pugh speaking in front of me to staff and saying "We're going to document everything", yet, still no help. Not once did they ever have a manifestation hearing like when she was at Toby Farms. I always felt supported when I was working with Mrs. Cogsdell. Mrs. Patterson, my daughter's therapist, said she has been unable to even meet with Ranisha when she comes to school and she tells me she has even suggested to the school to have a manifestation meeting for Ranisha.

My daughter has been out of school since the beginning of December. Unfortunately this school year I've had no level of support and my daughter is unsafe in school. I know she will fight that, she has her problems. She has some problems too. Now the students are coming to my house, I have two police reports that I had to finish filing tomorrow morning. The police officer called me back and I had to be there at nine o'clock tomorrow morning. One had six girls just knocked on my door this morning when I was at the drug store and yet the school is aware but no recourse is ever discussed by my child. Not to mention the citation fines and court dates I have incurred. I'm truly concerned about another parent sharing with me that Mrs. Olden showed her personal information such as a list of students in the classroom who had IEPs, which is confidential information. Finally, minority has been trying to contact the dispute lawyers who is handling special education for a while. No success. I need help, I mean I've been trying to work with them. I'm at the school more than I'm home. I came downstairs to talk to administration and while they had us on the loud speaker, Mr. Brown talked to me like I was a dog. Dr. Willis told him, "You have to tell her, you can't do this." He said, "I'll do what I want to do." So after that they got into it, she said she's going to go to his boss. And again, I was left out of everything, still no reports of anything. And I'm coming here to help to get some kind of resolution because with one thing I know about Toby Farm, it was hard, I was there, we've worked through it and worked through it. I was there, became, what was the suggestion? We went through the IEP, we worked hard. It worked. She still wasn't in school for all together, maybe three months. For three months out of the whole year. Just getting bits and days here. And I'm saying that she, like I said, she's not perfect, but the kids are hitting her and she's hitting them back. I'm telling her that's not the way to handle it.

Dr. Juan Baughn - Ms. Watley, right next to you is our director of special education.

Ms. Watley - I already talked to Scott last Friday. I've been talking to him too. I've been in a meeting and talking with Scott. My lawyer has and I have...

Dr. Baughn – Ms. Watley, that is not Scott. Scott is our Special Education lawyer. This is the director of special education, Mark McIntyre.

Ms. Watley - Oh, Scott. I talked to him Friday and about the home bound situation and I mean she can't come here, they're coming at my door.

Dr. Baughn – When you say administration, I don't know who that mean.

Ms. Watley - Well I talked to the special education, but when the stuff was happening in eighth grade, I came down here numerous times that this is not the first year that's been happening and I left numerous messages with, I asked to speak to you, but then the secretary took all the information and I never had no resolution. Nobody ever called me, even though when she gets suspended, I leave out maybe two or three times. I had got the list of suspension, how many days? All the rest of the days, they tell me they're going to send it in the mail and I never received it. After the second day I'm coming back here, you'll get four days come, I still didn't receive it. The fifth day I'm bringing her back to school because you all didn't send me a paper. So, and that's how they're playing with me back and forth.

Dr. Baughn – Well, listen, you're going to have a personal conversation with Mr. McIntyre tonight. So we'll have to wait and then if you still have that then call my office.

Dr. Gregory Thornton - Thanks. Thank you very much for sharing your concern and certainly will be a priority as we move forward and that priority, we will begin working very closely tonight. If we're able to spend a little time to meet with my colleague or if necessary, we can simply run one in the morning. It's your choice. I know family sometimes has to be tended to. I understand. Thank you for coming. Thank you for sharing. I believe you're in good hands with the gentleman that's right across from you.

Jonathan Raheem King - Good evening everyone, I'm not going to be long. My name is Jonathan Raheem King. I have an organization/company called Safe Corridors and I just wanted to put it on the record that I am awaiting for the school district to make the decision on how they can move forward, God willing on hiring our company to help our children here be safe at Chester Upland School District. I am an alumnus of this school. I graduated in 1983 even though my company is at different places, I have very much, well and concerned. I'm born and raised here for the safety of our children in the City of Chester. My program is improvement and evidence based program that it works and where I worked at, we really don't have much crime at all. So I just wanted to come here today to the meeting to express my great concern about it. And you know, we want to see how we can help all the people, all the men and women that work for me, our own residents of the city and know the children. They own the process and the protocol. And I've been doing this a long time. Thank you. May I leave my card with you?

Dr. Baughn – I have your card. I have your proposal and your proposal is under advisement and when, and if, we can do something with that, we will give you a call. So I mean it, and everyone in this room and everyone around this table have the same concern you do about keeping our youngsters safe. So the fact that you haven't heard from me has nothing to do with who wants to keep each other safe, has a lot to do with some other things.

C-5 Approval to adopt the Accelerated Budget Opt Out Certifying Tax Rate Within Inflation Index

The purpose of this resolution is to allow the school district to follow normal budget procedures, and dispense with the more complicated, expensive, and accelerated Act 1 budget requirements. This option is available only to school districts that are certain the next year budget can be funded without increasing the real estate tax rate by more than the index (and therefore without seeking approval for any index limit exceptions). This resolution may be adopted after the preliminary budget is available, or the board has sufficient information to be certain the budget can be funded by a tax increase within the index. For fiscal year 2020-21, the resolution must be adopted no later than January 31, 2020.

Background. Act 1 § 311(a), 53 P.S. § 6926.311(a), requires an accelerated budget adoption timeline and procedure unless a school district, no later than 110 days before the primary election, adopts a resolution containing the certifications incorporated in this resolution. The deadline this year is January 31, 2020. After adoption of a resolution containing such certifications, § 311(d) authorizes a school district to comply with pre-Act 1 budget adoption rules as set forth in School Code § 687, 24 P.S. § 6-687. The School Board has reviewed the school district preliminary budget or has other information sufficient to make a determination that the budget for the next fiscal year can be funded based on maintaining current tax rates or increasing taxes by an amount less than or equal to the Act 1 index. In lieu of the Act 1 budget adoption timeline and procedure, the School Board wishes to make the required certifications and comply with pre-Act 1 budget adoption rules.

RESOLVED, that the Board of School Directors of the Chester Upland School District, makes the following unconditional certifications:

- 1. The school district's various tax levies and other revenue sources will be sufficient to balance the school district final budget for the next fiscal year (2020-21) based on maintaining current tax rates or increasing tax rates by an amount less than or equal to the Act 1 index applicable to the school district as calculated by the Pennsylvania Department of Education. This conclusion is based on the school district preliminary budget or other information available to the School Board.
- 2. The applicable index for the next fiscal year is 4.1% and the School Board will not for the next fiscal year increase the rate of its real estate tax, or any other tax for the support of public education, by an amount that exceeds the applicable index.
- 3. The School Board has to date and in the future will comply with the rules set forth in School Code § 687 for adoption of the school district proposed and final budgets for the next fiscal year.
- 4. The School Board understands that the school district will not be eligible to use Act 1 referendum exceptions for the next fiscal year.
